## WORK OF SEWING TRAINING CENTER

- 1- The Woman Who Opening A Sewing Training Center Should Have Complete Knowledge Of Sewing. Qualification Should Be High School And Certificate Of Tailoring Training Issued By Any Recognized Institute.
- 2- Every Women Sewing Trainer Will Have To Pay Rs.500/- As Vehicle Transportation Registration Fee.
- 3- 3- 20 To 50 Students Will Be Trained At Each Training Center.
- 4- All The Trainees Getting The Training Will Have To Pay The Registration Fee As Per Their State.
- 5- Sewing Machine Distribution And Training Will Be Given By The Organization And The Trainee Will Be Given A Gift Voucher Of Rs. 5000 / - For Online Shopping Only And After Use The Voucher Rs. 500 /- Per Voucher TDS And Admin Charge Will Be Deducted And Provided In The Account Of The Partner. If The Given Voucher Is Not Used By The Trainee, Then The Institution Will Not Be Responsible For Voucher Payment. NGO Also Partner And Block Coordinator, Will Not Pressurize Paryavaran Foundation For Any Kind Of Voucher Payment Will Be Given As Per Rules.

**8- It Will Be Mandatory For The Sewing Trainer To Give Sewing Training For 3 Hours In A Week At His Center. Total Training Will Be Of 12 Hours.**

**9- The Sewing Trainer Has To Collect Application Fee, Training Fee From Each Trainees.**

**10- The Sewing Trainer Will Have To Distribute Certificates To Each Trainee. 11- Sewing Machines Will Be Distributed To Sewing Trainer At All Centers.**

**Note: The Trainee Should Deposit The Training Fee Only When The Sewing Machine Is Available At The Sewing Center, Otherwise The Organization Will Not Have Any Responsibility.**

## **Terms & Condition**

- 1- If The Sewing Trainer Charges More Than The Prescribed Fees Of The Institution, Then She Herself Will Be Responsible. **MAYA BAI LODHI FOUNDATION** Will Not Have Any Responsibility.
- 2- Whatever Registration Fee Will Be Given By The Sewing Trainer To **MAYA BAI LODHI FOUNDATION**. Once The Application Is Registered, It Will Not Be Returned Under Any Circumstances As Their Trainer Certificate Is Issued.
- 3- If Sewing Trainer Does Not Register In The Training Center, Then He/She Has No Right To Distribute Sewing Machine On Behalf Of **MAYA BAI LODHI FOUNDATION**
- 4- The Sewing Trainer Shall Render His/Her Services In Accordance With All Instructions, Procedures, Guidelines Issued From Time To Time And To The Satisfaction Of The **MAYA BAI LODHI FOUNDATION**. The Sewing Trainer Will Not Be In A Position To Take Legal Action Against The **MAYA BAI LODHI FOUNDATION**
- 5- The Sewing Trainer Will Not Have The Right To Give Any Written Material.
- 6- If She Is Found Providing Any Material Then Legal Action Can Be Taken Against Her.
- 7- Candidate Should Minimum Of 18 Years Old.
- 8- The KYC Document Is Mandatory For All Candidates (PAN Card, Aadhar Card, Aadhar Link Phone Number & Bank Account ).
- 9- The Organization Will Make This Application Free Of Cost.
- 10- After Completing The One-Day Sewing Machine Operating Training Candidate Is Eligible To Apply For The Sewing Machine.
- 11- The Organization Provides The Sewing Machine To All Applicants At A 75% Discount Price With The Help Of CSR Donation.
- 12- The Candidate Should Pay @500/- For The Transportation Of The Machine But The Organization Also Helps With The Same Amount. (The Organization Deposits The Same Amount To The Applicant's Account With The Help Of The Organization ).
- 13- The Applicant Should Pay The Machine Price After Receiving The Machine ( Only 25% Of The Machine Price ).

**Note: Trainees Should Deposit The Fee Only If The Sewing Machine Is Available At The Sewing Center, Otherwise Organization Will Not Have Any Responsibility**

## Partner/Coordinator Work

- 1-The Partner/Coordinator Will Have To Work In The Sewing Training Centers Of His/In Zonal District. In Which The Sewing Trainer And Block/Taluka/Mandal Partner / Coordinator Will Have To Make Their Own Arrangements.
- 2 -All Block/Taluka/Mandal Partner/ Coordinator Of Their Zonal District Will Have To Start Work In The Gram Panchayat Within 10 Days.
- 3-On Behalf Of **MAYA BAI LODHI FOUNDATION**, NGO Will Be Required To Open Sewing Training Center In All Block/Taluka/Mandal And Gram Panchayat Of Their Zonal District And Registration Of Trainees Will Be Mandatory Only Then The Amount Determined By **MAYA BAI LODHI FOUNDATION** Will Be Payable To The NGO.
- 4-Partner/Coordinator Will Have To Target Only 1280 In His Work Area, After Registers 650 Trainees At All The Training Centers, Sewing Machine Distribution Will Start At Those Centers
- 5-If The Partner/Coordinator Suspends Any Sewing Trainer From His/Her Post, He/She Will Inform The Same To His/Her Higher Authority And Inform The Sewing Trainer In Writing.
- 6 -If The Partner/Coordinator Takes Additional Fees From Anyone In His Zonal District, Then Legal Action Can Be Taken Against Him And He Can Be Suspended From The Partnership.
- 7- It Is The Responsibility Of The Partner/Coordinator To Get All The Sewing Centers Registered.





8 - Minimum 20 Trainee, Maximum 50 Trainee At The Centers, The Center Will Not BeComplete If The Online Registration For The Trainee Is Not Done.

- The Partner/Coordinator Will Have To Conduct Sewing Training In All Blocks Of Its Work Area And Associate Ngos Will Have To Register Their Selected Work Area OrganizationBy Visiting The Website Of Paryavaran Foundation. The NGO Registration Fee Will Be Rs 50,000/- Which Will Be Done Through A Link And This Fee Will Not Be Refunded Under Any Condition. And Get One Sewing Machine Sample Kit (A)1. Sewing Machine (B)2. Bener. (C)50 Id Card Holder And Dori (D)1. Dairy (E) 2. T Shirt (F) 20 Sticker (G)200. Form (H) 200 Pamphlet

9 - If The Partner/Coordinator Does Not Complete His Work, No Fixed Amount Will BeGiven To The Partner/Coordinator .

11- If The Partner/Coordinator Works In An Illegal Manner, His/Her Contract Will Be Cancelled.

12 -The Partner/Coordinator Will Have To Follow All The Terms Of Their AgreementProperly.

13 - Legal Action Can Be Taken Against Any Partner/Coordinator Who Misuses The TermsAnd Conditions Written In The Agreement.

14- It Will Be The Responsibility Of The Partner/Coordinator To Apply For Sewing TrainingCenters In All The Districts And To Reach The Sewing Machine To Those Centers.

15 - If The Partner/Coordinator Can Not Implement The Trainee's Application At All The Centers, Then In This Case Your Work Order Will Also Be Destroyed By ParyavaranFoundation (1) Rs. 3637/- From Each Trainee Only When The Sewing Center Is Complete And Sewing Machine Is Available At The Sewing Center.

17 - It Is Mandatory To Operate A Sewing Center In Each Block Of Your Zonal District.

18- After The Registration Of 650 Trainees Is Completed, Distribution Of Sewing MachinesWill Be Started One By One At All The Centers Of The District.

19 -The Partner/Coordinator Will Have To Work With The Block Coordinator And

20- Legal Action Can Be Taken If The Partner/Coordinator Misuses Any Written Material Of **MAYA BAI LODHI FOUNDATION**



- 22 -All Components, Including Their Directions And Foregoing Modifications, Are Provided In Accordance With This Agreement And Are Not Limited To Any Party's Misuse, Including Any Pattern, Copyright, Trade Secret, Trade Secret Or Other Proprietary Right.
- 23 -The Plans And Other Information Hereinafter Collectively Referred To As The Information In Which The Beneficiary Service Is Provided By The Service Provider Paryavaran Foundation. This Agreement Shall Be The Sole Property Of The Foundation And Is Strictly Private And Confidential In Nature And Confidential By The Service Provider.
- 24 -It Has Full Power And Authority To Enter Into This Agreement And To Perform The Services. To Perform The Duties Of The Services, Under This Contract, There Is An Essential Infrastructure, Including Necessary And Timely Testing Of Contingency Resources And Systems.

### BLOCK/TALUKA/MANDAL PARTNER/COORDINATOR WORK

1 The Block/Taluka/Mandal Partner/Coordinator Will Have To Work In The Sewing Training Centers Of His Partner/Coordinator In The Block/Taluka/Mandal Of The Sewing Trainer Will Have To Make His Own Arrangements.

The NGO Partner /Coordinator Goto Website [WWW.MAYABHAILODHIFOUNDATION.ORG](http://WWW.MAYABHAILODHIFOUNDATION.ORG) For Registration This Fee Will Be Rs.12,500/ Will Be Done Through Online And This Fee Will Not Be Refunded Any Condition.

1- On Behalf Of **MAYA BAI LODHI FOUNDATION** Ngos Will Be Required To Open Sewing Training Center In Their Block/Taluka/Mandal And Gram Panchayat And Registration Of 160 Trainees Will Be Mandatory Only Then The Prescribed Amount Will Be Payable By **MAYA BAI LODHI FOUNDATION**

3-The Block/Taluka/Mandal Partner/Coordinator Will Have To Target Only 260

In His Work Area, After Registers 160 Trainees At All The Training Centers, Sewing Machine Distribution Will Start At Those Centers

4-Every Month One Training Center 1to 20 Sewing Machine Distribute All

Trainees Fee Deposit In Trainer A.C For Umbrella Model (TA 1/95 T 10) = Rs.3637/-

5-If The Block/Taluka/Mandal Partner/Coordinator Suspends Any Sewing Trainer From His Post, He Will Inform It To His Higher Authority And Inform The Sewing Trainer In Writing.



- 1- Minimum 20, Maximum 50 At The Centers, The Center Will Not Be Complete If The Online Registration For The Trainee Is Not Done And Each Sewing Trainee Will Have To Pay Rs.500/- Online As Registration Fee.
- 2- If The Block/Taluka/Mandal Partner/Coordinator Does Not Complete His Work, Then No Fixed Amount Will Be Given By The Organization.
- 3- If The Block/Taluka/Mandal Partner/Coordinator Works In An Illegal Manner, Then His Charge Will BeCancelled.
- 4- The Block/Taluka/Mandal Partner/Coordinator Will Have To Follow All The Rules Of His Agreement Properly.
- 5- If Any Block/Taluka/Mandal Partner/Coordinator Takes Extra Fee From Some One In His Work Area And Misuses The Terms And Conditions Any Written In The Agreement So Legal Action Can Be Taken Against Him And He Can Be Suspended From His Post.
- 6- If The Block/Taluka/Mandal Partner/Coordinator Can Not Implement The Trainee's Application At All The Centers, Then In This Situation Your Work Order Will Also Be Destroyed By **MAYA BAI LODHI FOUNDATION**.
- 8- It Is Mandatory To Operate A Sewing Center In Each Gram Panchayat Of YourBlock/Taluka/Mandal.
